Leuchtengläser besitzen einen hohen Anteil an Handarbeit. Herstellungsbedingt kann es dadurch zu Luft- oder Partikeleinschlüssen oder leicht abweichender Optik kommen (z.B. der Lackierung, Ausformung). Auch ist eine unterschiedliche Wandungsstärke möglich, was zu einem nicht ausgewogenen Gewichtsverhältnis im Glas führt. Eine dadurch bedingte leichte Schiefstellung, z.B. bei Pendelleuchten ohne Ausgleichsmöglichkeit, ist daher normal. All diese genannten Punkte sind ein Erkennungsmerkmal für ein individuell gearbeitetes Produkt und stellen keinen Mangel dar.

Luminaire glasses have a high proportion of manual work. Due to the manufacturing process, this can lead to air or particle inclusions or a slightly different appearance (e.g. the paintwork, molding). Different wall thicknesses are also possible, which leads to an unbalanced weight ratio in the glass. A slight misalignment caused by this, e.g. in the case of pendant lights without the possibility of compensation, is therefore normal. All of these points are a distinguishing feature of an individually manufactured product and do not represent a defect.

Les verres des luminaires ont une forte proportion de travail manuel. En raison du processus de fabrication, cela peut entraîner des inclusions d'air ou de particules ou un aspect légèrement différent (par exemple la peinture, le moulage). Différentes épaisseurs de paroi sont également possibles, ce qui conduit à un rapport de poids déséquilibré dans le verre. Un léger désalignement causé par cela, par exemple dans le cas de suspensions sans possibilité de compensation, est donc normal. Tous ces points sont une caractéristique distinctive d'un produit fabriqué individuellement et ne représentent pas un défaut.

I vetri degli apparecchi d'illuminazione hanno un'alta percentuale di lavoro manuale. A causa del processo di produzione, ciò può portare a inclusioni di aria o particelle o ad un aspetto leggermente diverso (ad es. la vernice, lo stampaggio). Sono possibili anche diversi spessori di parete, il che porta a un rapporto di peso sbilanciato nel vetro. Un leggero disallineamento causato da ciò, ad esempio nel caso di lampade a sospensione senza possibilità di compensazione, è quindi normale. Tutti questi punti sono una caratteristica distintiva di un prodotto fabbricato individualmente e non rappresentano un difetto.
